The Project Director (PD) welcomed all the officers of KNNL, CADA, AC-IWRM & the Project Support Consultants (PSC) to the meeting. The progress of PSC with regard to tranche-1 activities and the preparation of tranche-2 activities were reviewed. The team leader of PSC, Mr. Ashok Raut presented the progress made by PSC. The proposal for recruiting Support Services Team (SST) is submitted by M/s SMEC for approval. The SST proposal was discussed and SMEC were informed to substantiate the cost estimate with respect to remuneration and out of pocket expenses and to submit a draft sub-contract agreement as per the sample provided by ADB for hiring of individual consultants and submit competitive CVs for the same.

The CMS recommended a site visit for KNNL engineers to Sharda Sahayak Canal System and Lower Ganga Canal, UP before the onset of monsoon. The CE, UTP was requested to take action to depute the concerned Engineers to visit the Projects in UP.

Mr. Jithendra Agrawal, MIS Specialist, PSC presented the draft of the Program Performance Monitoring System (PPMS) and the Project Management Information System (PMIS) consisting of three modules; financial, physical and procurement plan. The team leader said that the PPMS Module would be submitted by the first week of June.
