2. **The Executive Engineer, Karnataka Neeravari Nigam Limited, No. 1, Tungabhadra Reservoir Division, Munirabad** invites the bids from prospective bidders for the proposed project on behalf of the **Project Director, KISWRMIP & Managing Director, Karnataka Neeravari Nigam Limited** (the "Employer").
3. Participation has specific Construction Experience in Key Activities as follows (a) has specific experience of having Canal lining (paver) works of 30,500 square meters in any one financial year during the last 5 financial years (i.e., from FY 2016-17 onwards) (b) has specific experience of having RCC M-20 and above grade works 13,400 cum in any one financial year during the last 5 financial years (i.e., from FY 2016-17 onwards)
4. **Open Competitive Bidding (OCB)** will be conducted in accordance with ADB's **Single-Stage: Two-Envelope** bidding procedure and is open to all bidders from eligible source countries.
5. The bid document shall be available for download from 11:00 hours on 08-11-2021 to 15:00 hours on 08-12-2021 from the website <https://eproc.karnataka.gov.in>.

6. Bids shall be submitted in electronic mode on the Government of Karnataka's e-procurement portal: <https://eproc.karnataka.gov.in> by 08-12-2021, 15:00 hours Indian Standard Time (IST) ("e-system deadline"). The e-procurement portal has all the user manuals, guides, and FAQs to facilitate understanding and use. To participate in the bidding, it is mandatory for the Bidders to have a valid registration of their firm/ JV with the e-procurement portal and to have an active user ID & password. Registration requires an annual registration charges through the e-payment gateway. Bidders should also have a valid digital certificate issued by the national certificate authorities, which have link at <https://eproc.karnataka.gov.in>. The complete Bid document can be viewed/downloaded by the Bidder from the e-procurement portal. Bidders may peruse the details in the bid document.
7. Bid preparation and submission requirements are detailed in the Bid Data Sheet. Bidders shall submit their bids electronically only and manual submissions will not be accepted. Refer Section 2 – Bid Data Sheet for additional information.
8. Bids will be opened electronically after the 48-hour lock-in period after the online bid submission deadline.
